AKC Rules & Exhibitor Notices

The American Kennel Club Rules and Regulations will govern this show and exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Show Premium List.

Rules Applying to Dog Shows Effective July 1, 2016 - CHAPTER 11, SECTION 1.

No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. See <u>http://www.akc.org/pdfs/rulebooks/RREGS3.pdf</u> for complete detail of the rule change.

A recording fee of 50¢ for each dog and an AKC Event Service Fee of \$3.00 will be **required** for each record-able single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). An AKC recording fee of \$2.50 lot entry and \$2.00 additional entry of same dog will be required for each entry in

of \$3.50 1st entry and \$3.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 3). These Fees are paid to the American Kennel Club.

The Vizsla Club of the Central New England assumes no responsibility for the owner or owner's agent entering a dog in a class in which it is not eligible to compete, or for entering the same dog twice. The club and its members assume no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. Returned checks do not constitute a valid entry. The returned items must be made good by cash or money order before the dog will be allowed in the ring.

Entries not on official AKC Entry Forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form are not acceptable. **INCLUDE ONLY AKC/VCA TITLES ON ENTRY**

Exhibitors identification and judging programs will be emailed to the address given on the entry blank. If not received within the time prior to the show, notify Show Secretary at address on the entry form.

Owners are to have their dogs ready to go into the ring promptly, so judging will not be delayed. Dogs only need to be present for their own judging. Dogs not needed for further judging are excused. It is the responsibility of the exhibitor to have his/her dog ready at ringside when the steward calls the class. Owners and/or their handlers are responsible for making sure their dog is present in the ring. This means it is not the responsibility of the ring steward, nor any agent, nor the show-giving club to locate any dog, its owner or handler. There is no American Kennel Club or club rule requiring a judge to wait for an owner or handler to enter the ring.



AKC Rules & Exhibitor Notices, cont'd

Owners must familiarize themselves with the agreement of the American Kennel Club referred to on the reverse side of the entry blanks that accompany this premium list. Rule books are available at the show or individual copies may be obtained free from the AKC, 8051 Arco Corporate Drive, Suite 100, Raleigh, NC 27617-3390.

The club and its officers or members will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes. It is distinctly understood that every dog at this show is in the care, custody and control of its owner or handler during the entire time of the Specialty weekend. The club, its officers or members will not assume any responsibility for any loss, damage or injury sustained by an exhibitor or agent.

Entry fees shall not be refunded in the event a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the show committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no entry fee refund for duplicate entry or for bitches in season.

The Vizsla Club of Central New England may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the club or any official thereof.

Entry fees will not be refunded if it is impossible to open or complete the show because of riots, civil disturbances, fires, extreme and or dangerous weather conditions, an act of God, public emergency, acts of a public enemy, or other acts or cause beyond the control of the club or the Show Secretary.

Foreign exhibitors must submit entries with checks drawn on U.S. accounts or with international money orders in U.S. funds.

Returned checks/invalid credit/debit cards do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Personal checks will not be accepted as replacements for dishonored checks or invalid credit/debit card payments. The Superintendent will add a collection fee to the amount of each returned check & credit/debit card for completing the transaction and/or reprocessing the entries. Anyone who submits any payment to the VCCNE, that is later returned by the bank or charged back to the VCCNE by the Show Secretary for any reason, will be assessed a \$30.00 returned item fee by the VCCNE. Subsequent returned checks & credit cards from the same exhibitor may result in that exhibitor being placed on a cash only basis.

Refunds of \$3.00 and less will not be issued, due to the costs of processing. An administrative fee will be charged for all cancellations or changes made prior to close of entries.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen, and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent or Show Secretary is not able to cash checks.



AKC Rules & Exhibitor Notices, cont'd

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Mail all entries with fees to the **address on the official AKC Entry Form**. Please notify Show Secretary of any change of address. Facsimile Machine entries for this show can not be accepted. Special delivery & overnight delivery should be **marked as "NO" signature required.**

Exhibitors are governed by all rules or regulations of the American Kennel Club, civil authorities and/or building or location restrictions.

Dogs that according to their owners' records have completed requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made to the Show Secretary or Superintendent one-half hour prior to the start of regular conformation judging.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Owners are strongly advised to have all vaccinations current on their dogs. Many states require a proof of rabies certificate. Please bring with you all proof of vaccinations. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Exercise pens may be set up only in posted or approved areas. There is plenty of green space available for properly exercising your dogs.

The Vizsla Club of Central New England, through the generosity of its members and friends, offers prizes in regular and non-regular classes in breed, and junior showmanship competition. Contributors to the General Fund and specific trophy sponsors will be listed in the Events Catalog. The VCCNE reserves the right to substitute an alternate trophy of equal or greater value if necessary.

All trophies must be picked up on the day of the show, except where otherwise stated. Owners and/or agents are responsible for picking up trophies. VCCNE reserves the right to substitute trophies of equal or greater value for any trophy listed.

"We don't need another dog!" Those famous last words were said back in late 1990 when Mark wanted to add a Vizsla to our American cocker spaniel (obedience dog) and American water spaniel (hunting dog) household. But in January of 1991, we added our first Vizsla, Rosie, and that's when the addiction began.

I took Rosie to an obedience class and more than one person said, "You should be showing that dog in conformation." I entered my first show in Milwaukee, WI, with one lesson, two nights before the show. Needless to say, I got 3rd place out of 3. The next day Rosie won her first point, however, and I was hooked. Since then, I have put championships and/or grand championships on several Vizslas, a German Wirehaired Pointer, and a French Bulldog. I've participated in conformation, obedience, agility, hunt tests, field trials, and most recently, barn hunt with our dogs.

My husband, Mark, was the primary handler for hunt tests and field trials, but I have titled a few dogs in hunts tests and handled dogs in field trials a few times (as a walking handler) when he was not available. We had our first litter of Vizslas under the kennel name of ReMark in 2002. Our last litter was in 2018. Each litter was bred with an eye toward producing a Vizsla that conformed to the standard, would be a great companion and could perform as a hunting partner.

I have been involved in Sporting Dogs for over 30 years. Much of my success as a Breeder and Owner has come from Pointing breeds. I have bred multiple generations of All Breed Best in Show and multiple National Specialty winning German Wirehaired Pointers culminating with a Top Dog of All Breeds in 2012. My dogs have earned JH, SH, MH as well as NAVHDA NA & UT Titles.

Most recently my Italian roots lead me to the Spinone Italiano. I own the Top Winning Spinoni Italiani in AKC History. She finished 2022 as the #3 Sporting Dog and winning the Sporting Group at the AKC National Championship in Orlando.

As a breeder, I place a high value in my breeding program on animals that are Dual Purpose & Versatile. I am passionate that we must take our "keepers" higher than Junior and NAVHDA NA. Higher levels of training provide us with a window into not only trainability but mental stability. We cannot trade form for function. We must nurture both in our breeds.

As an AKC judge I have been honored to judge the German Wirehaired Pointer and Lagotto Romagnolo National Specialties, as well as the Chinese Crested Club Top 20. I have also judged specialties in many Sporting breeds.

I live on a farm in Lovettsville, Virginia with three Spinoni Italiani, a Pointer & three Chinese Cresteds.

Under the Bajnok prefix, François Bernier bred and exhibited German Shorthaired Pointers, Vizslas and Pointers since 1993, and produced many champions and Top Dogs, including the 2000 Vizsla Canada National Specialty winner MBISS, NBISS Am CH/Can Gr. CH Bajnok Dances with Falcons FD CGN, JH ROM (Toldi) as well as the GSP Canadian National Specialty winners in 2006 and 2015. In addition to conformation, François has participated in obedience and field events with his dogs, both in Canada and the United States. The Four-to-Six Month Puppy competition shall be a combined class for Vizslas only, that are four months of age and over but under six months on the day of the event.

- ELIGIBILITY REQUIREMENTS -

- AKC registration number or an AKC litter number will be required for all entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may not personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition. Dogs that are owned or co-owned by the forenamed may compete in this competition but must be handled by a non- professional handler.
- Professional handlers are defined as any person who belongs or has belonged to a
 professional handlers' organization, distributed rate cards, or otherwise advertised
 or represented themselves as handling dogs for pay within the last five years. Dogs
 may not be exhibited by current assistants and household members of a
 professional handler.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and AMATEUR STATUS requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

Junior Showmanship

Novice: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

Open: This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present. Junior Handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show. Bitches in season are not eligible to compete. No entry may be changed or canceled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another provided this transfer is made by the Superintendent or Show Secretary at least one half-hour prior to the scheduled start of any Junior Showmanship class at the show. A dog may be substituted for another provided the Superintendent or Show Secretary is notified in writing at least one half-hour prior to judging of any junior showman-ship classes at the show.

Junior, Intermediate and Senior Classes: Each of the regular classes are divided by age into Junior, Intermediate and Senior Classes. A Junior Class shall be for boys and girls who are at least 9 years old and under 12 years old on the day of the show. The Intermediate class shall be for boys and girls who are at least 12 years old and under 15 years old on the day of the show. The Senior Class shall be for the boys and girls who are at least 15 years old and under 18 years old on the day of the show.

Master Class: For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior Handler awards with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for the year has passed, all participants return to the Open Class to compete for the following year.

AWARDS

Best Junior Handler: The VCCNE offers a prize for Best Junior Handler. The Junior Handler placed first in each of the regular Junior Showmanship Classes shall automatically be eligible to compete for this prize.

Reserve Best Junior Handler

Winning first place in an Open Junior Showmanship Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes which have been approved to date by AKC. Write to the American Kennel Club, 8051 Arco Corporate Drive, Suite 100, Raleigh, NC 27617-3390.

Note: Junior handlers must put their AKC junior handler number on the entry blank. To get a junior handler number, call the American Kennel Club (919) 233-9767. Be sure that all information for Junior Showmanship Classes is entered on front and back of entry form.





The AKC National Owner-Handled Series is a non- titling competition for dogs that are exhibited by their owners that are not professional handlers. All dogs that are owner-handled and are not owned or exhibited by professional handlers* meet the requirements for this competition.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog.

Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in any competition during the entire show.

*Professional handler is any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay with the last five years.

**A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

OWNER-HANDLER BEST OF BREED SELECTION

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed.
- If the Best of Breed winner in not eligible for Owner-Handled competition and the Best of Opposite Sex to the Best of Breed is eligible, the Best of Opposite Sex to Best of Breed will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs or the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than Winners Dog & Winners Bitch are eligible to return to the ring.

If at the end of the 90-day period the championship of a dog has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by the AKC.

Neutered dogs and spayed bitches are allowed to compete in Veterans and/or any other single entry non-regular classes at VCCNE's independent specialty shows.

· NON-REGULAR, MULTIPLE ENTRY CLASSES -

Stud Dog and Brood Bitch

(Saturday AM Show & Sunday PM Shows ONLY)

For dogs or bitches who have two of their Get entered in a Regular Class, Best of Breed Competition, or another Non-Regular Class. The stud dog or brood bitch must appear in the ring with his/her get and be entered in the Stud Dog or Brood Bitch Class as a first entry, they need not be entered in other classes. The owner of the stud dog or brood bitch need not be the owner of the get. The awards will be based on the merits of the get.

As the judge's decision in these classes will be based on the merit of more than one dog or bitch, the dogs or bitches making up this entry judged first in the class will not be eligible to compete for Best of Breed by virtue of having won this class.

While the merits of the stud dog or brood bitch are not to be considered in the placement of the entry, the stud dog or brood bitch must be examined to determine if it has a condition that would require disqualification or excusal under the Dog Show Rules, AKC policy or the standard for the breed.

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
